Learning Experiences

Medicare Formulary Management

Evaluate coverage determinations, drug literature reviews, therapeutic classes, and implementation of CMS program updates.

Commercial Formulary Management

Review coverage determinations and benefit designs.

Pharmacy & Therapeutics Committee

Participate in quarterly P&T Committee meetings, including presentations of relevant new drug therapies that will affect the plan over the upcoming year

Pharmacy Accounts and Sales

Share in discussions regarding benefit design and sales, guidelines for appropriate practices regarding sales, and open enrollment for Marketing and Sales

Residency Research and Analytics

Develop a research project and present at a regional or national conference.

STAR Measure Management

Monitor plan effectiveness for specific STAR measures, develop new evaluation tools to monitor plan improvement of STAR scores, and create new approaches to improve ratings.

Pharmacy Continuing Education

Develop and present a 1-hour continuing education presentation to help with company-wide training and learning opportunities

Pharmacy Benefit Management

Coordinate execution of pharmacy benefits with the current Pharmacy Benefit Manager, assist in benefit programming and drug utilization review, evaluate current processes and trends, and assist in the development of new strategies for upcoming plan changes.

Medication Therapy Management

Assist in the development and submission of the annual MTM program, review monthly MTM program reporting, and participate in the MTM provider annual delegated function audit.

Interdisciplinary Team

Review complicated patient cases and medication regimens for improvement, adherence, and barriers with a team of doctors, nurses, social workers, and pharmacists to improve patient care and decrease hospitalizations.

Opioid Misuse Review

Assist in reviewing patient cases each quarter that present on a report to determine if the patient is being appropriately treated.

Medication Adherence

Assist the medication adherence team to improve patient care by recommending guideline therapy and overcoming compliance, social, and education barriers
